### Course description and objectives

The aim of the course is to provide analysis on regional and urban economics. The course addresses several issues such as households' and firms' location strategies, urban development, urban policies, local taxation, urban transport, real estate prices and sustainable city projects. The course provides the student a strong theoretical analysis of regional and urban development mechanisms but also covers important empirical work, with several examples and study cases.

### Prerequisites

The students that can follow this course may come from different fields such as economics, management, business administration, political sciences, mathematics, sociology, geography, regional studies.

### Learning outcomes

- Identify the economic forces and principles which explain why cities exist.
- Define the location choices of firms.
- Explain how land and housing markets function.
- Describe location equilibriums.
- Identify urban policy issues and outcomes.
- Identify urban environmental issues

### Assignments and grading

- 50% of the grade comes from group work on a given topic and the presentation of its outcome.
- 50% of the grade comes from a final exam.

The numerical grade distribution will dictate the final grade. The passing grade for a course is 10/20.

**Class participation:** Active class participation – this is what makes classes lively and instructive. Come on time and prepared. Class participation is based on quality of comments, not quantity.

**Exam policy:** In the exam, students will not be allowed to bring any document (except if allowed by the lecturer). Unexcused absences from exams or failure to submit cases will result in zero grades in the calculation of numerical averages. Exams are collected at the end of examination periods.
